Trade Show in Hall A, Prairieland Park

Set up time: 5:00 pm- 8:00pm Tuesday, November 5th

7:00 am-9:00am Wednesday, November 6th

Exhibitor packages can be picked up at the registration desk during setup time.

Trade Show hours: 9:00 am - 5:30 pm Wednesday, November 6

8:30 am - 4:00 pm Thursday, November 7

- Booth tear down must not commence prior to 4:00 pm November 7th and must be completed by 9:00 pm on Thursday, November 7th.
- Deliveries will be accepted at the Prairieland Park no sooner than November 1. Should you wish to have a shipment sent, all materials should be shipped to-
